A meeting of Mells Parish Council took place on Tuesday 11 December 2012 at Mells Barn.

- 1. PRESENT: Mr E Costelloe (Chairman), Ms R Wallace (Vice Chair), Mrs M Jennings, Mr P Lowth, Mrs J Mann, Mr C Tye, Mr S West, Miss H Wynter
- 2. APOLOGIES FOR ABSENCE were received from The Countess of Oxford & Asquith. The Clerk sent her apologies for absence caused by illness. (Ros Wallace took the minutes in her absence). Absent: Vince Turner
- 3. COUNCILLOR ABSENTEEISM: The Chairman explained the operation of Section 85 of the Local Govt Act which led to the automatic disqualification of Councillor A Blanche-Martin due to 6 months' non attendance. This non attendance was due principally to the change of meeting dates following the appointment of a new clerk and was much regretted. Councillor P Lowth explained and defended the circumstances of the absence and the SALC advice they had received. Following this he advised the Council that with regret he was tendering his resignation in support of his wife. Following his resignation he left the meeting at 7.28pm.

It was resolved that the Chairman would write to both Councillors thanking them for their service to the Council and community.

- 5. **MINUTES OF THE MEETING** held on 13 November 2012 had previously been circulated. It was resolved that the minutes be adopted with the small correction of the date of the next meeting to read as 11th December not 1st December. The minutes were then signed by the Chairman.

6. MATTERS ARISING

- a) Quarry Liaison Committee: Steve West had attended the meeting at the end of October. Halecombe Quarry reported business was quiet with tonnage down by 50%. Investigations were being made into the balancing lake. A local resident had complained of noise and this had been followed up.
- b) **Speed Watch Progress:** there had been no response from the Parish Magazine nor the school. It was agreed to put up more notices in the Village.
- c) Gift of Grit Bin from Mells Village Shop: there was no update on this matter.
- d) **Leigh on Mendip Shrubs covering road sign:** Ros Wallace had spoken with the Leigh on Mendip Clerk to clarify the position of the sign. The matter would be progressed with Jeff Bunting.
- e) **Drainage Channel White Bridge:** Chris Tye's remedial works had proved effective and he would continue to monitor the situation.
- f) Encroaching verge by Primrose Cottage, Lower Vobster: the Clerk had been liaising with Somerset CC to come and inspect the site.
- g) **Vobster Bridge Length Restrictions:** the Clerk was in contact with Jeff Bunting and trying to set up a meeting on site with him, Steve West and Ros Wallace.
- h) **Gullies Old Post Office:** Ros Wallace had spoken with the owner of the Old Post Office who stated that it was the BT manhole cover in the road above the house from which water was streaming down the road. The duct needed rodding as far as the road gullies to clear the blockages. Clerk to contact BT.
- i) Clerk's Contract: due to the Clerk's absence this would be signed at the next meeting.
- j) Refilling of Grit Bins: Richard Branchflower will top up the grit bins when passing.

7. PLANNING

Mendip Planning Decisions

- a) **2012/2358** Felling of a Lime tree in a conservation area Rear of Bus Shelter, Manor House. No objection.
- b) **2012/2095** Create formal garden and shall Italianate pond Wadbury House. Approve with 2 conditions.

- c) **2012/0182** Proposed agricultural building including photo-voltaic panels Stone Ash Farm. Approve with 4 conditions.
- d) 2012/1893 Conversion of Grade II Listed building to a dwelling. Demolition of single storey workshop and erection of replacement of single storey extension. Squash Court, New Street. Approved with 5 conditions.

8. CORRESPONDENCE FROM SOMERSET COUNTY COUNCIL

- a) Wildlife & Countryside Act 1981 Modification of Order, The Parishes of Coleford and Mells - Ros Wallace confirmed the order had been made for the upgrading of the footpath in Upper Vobster to a bridleway but added that should there be any complaint it was likely the matter would be the subject of a Public Enquiry.
