Minutes of the meeting of Mells Parish Council on Tuesday 11 November 2014 at Mells Barn

2. APOLOGIES FOR ABSENCE: Mr E Costelloe – Chairman

- 3. **DECLARATIONS OF INTEREST:** None
- **4. PUBLIC PARTICIPATION** Resident wished to discuss the bus timetable and mobile phone signal in Mells. Discussed under Item 6.e) and 6.f)
- 5. MINUTES OF PREVIOUS MEETING dated 17 October 2014 had previously been circulated and it was resolved that the minutes be adopted. The minutes were then signed by the Vice Chair. Proposed John Earl seconded Alison Moir.

6. MATTERS ARISING

- a) **Vobster Bus Stop:** The post has been replaced. Clerk has contacted First Group for the sign to be replaced.
- b) **Overgrown vegetation opposite Primrose Cottage, Lower Vobster:** Buses are having to move out into the middle of the road to avoid the vegetation. Clerk to chase.
- c) Compacted gravel hump: Chris Tye to inspect and report to Clerk who will chase.
- d) **Bus Timetable Frome 'BUG' meeting:** Clerk has received a response from Somerset Highways who are unable to give further funding but has received no response from the First Group. Clerk advised resident to attend the Frome Bus User Group (BUG) meeting on Wednesday 19 November. A suggestion has been made by Frome BUG that it maybe beneficial for the rural villages to form their own group as their requirements differ from the town.
- e) **Mobile phone signal:** The government is looking to apply pressure on mobile companies to allow the public to roam freely between providers. This may not resolve all reception issues as signals would drop whilst the transfer between masts took place. Chris Tye reporter that booster signal boxes do allow users of Vodaphone and O2 in Mells to have a signal around their house and garden. David Heath MP would support the PC pursuing further action. Clerk has written to 7 surrounding parish councils asking about the mobile reception in their area. To date, only Buckland Dinham has responded and reported that reception in their area is generally acceptable but they have concerns about the broadband speeds. It was agreed to wait until next month to see if more responses are received before making a decision on how to proceed.
- f) Mells Park Estate Community Benefits Payments: The original email stated that this was an 'annual' grant. Clerk to establish whether this is correct and for how long the grant would be distributed as typically grants of this kind are given for up to 25 years. Ros Wallace reported that the Trust could accept the grant but explained that the Trust was unlikely to be running in 10 years due to the funds being insufficient for it to continue that long. It was unanimously agreed that the PC should accept the money and a specification of how the money should be spent would be decided.
- g) **Finger posts repainting:** For discussion at the next meeting.
- h) **Telephone box Mells Green repainting:** For discussion at the next meeting.
- i) Overgrown vegetation/Car park signs Recreation Ground: Clerk has been unable to contact Rob Symes who has been away. Chris Tye will advise Rob on what work is required.

2014/2080/OTS Land at Hillcrest, Somers Hill to Mells Green – outline planning permission for erection of dwelling house: John Earl and Ros Wallace met with the applicant on site. Large garden had adequate space for new property. Recommended approval of 'outline' planning.

2014/2193/TCA Prospect Cottage, Top Lane: Felling of Thuja tree in conservation area - no objections.

2014/2138/OTS: Acrewood, Little Green: Application for outline planning permission (with some matters reserved) for one detached dwelling sought for layout, scale and access. Concerns were
