- **MINUTES OF PREVIOUS MEETING** dated 14 July 2015 had previously been circulated and it was resolved that the minutes be adopted. The minutes were then signed by the Chair.

6. MATTERS ARISING

- a) **Mobile Phone signal/broadband:** Alison Moir has met with David Warburton MP who is very keen to move this forward and has indicated he would like to attend a PC meeting when he is available. Over 100 signatures have now been gathered. Alan Brady has also spoken to David Warburton MP and has arranged to meet with Jacob Rees-Mogg MP. All MP's are very keen to see this pushed forward. David Warburton MP also plans to meet with the Minister for Telecommunications.
- b) Flooding Bottom Lane: No further information.
- c) **Mells Daffodil Festival:** The Daffodil Committee is a sub-committee of the PCC. PC will write to PCC to clarify the intention of the committee. Chair will liaise with John Earl and Jan Seewooruttun.
- d) **Fingerpost Knaptons Hill:** This will be replaced. The give way lines are faint and the give way sign is obscured by vegetation. Chair to write to Avon and Somerset Police.
- e) **Raised cobblestone:** The cobblestone initially reported has been repaired. It is unknown whether the other cobblestones have also been repaired.
- f) **Noticeboard requiring varnishing Little Green:** No further information regarding the varnishing. The catch has become bent.
- g) **Activity by old BT Exchange Vobster:** The exchange has been purchased by a local carpenter who will be using it as a store. He is currently undertaking repairs to the roof and sleeps on site at night as the building is not fully secure.
- h) Litter bin by the Post Office and dog waste bin by Lutyens shelter: No further information.
- i) **Withdrawal of 184 bus service:** A new company is taking over the 184 route but it will terminate at Midsomer Norton allowing connection with the buses to Bath. Six buses a day will run through Mells. Clerk to put new timetable on the website.

- a) **Get your parish ready for the Local Plan Part II:** Mendip DC have supplied a questionnaire to guide Parish Councils in preparation for the Local Plan Part II. Parking, mobile phone signal, lack of public seating and gas supply were noted.

- 14.1 **Mobile Library service:** This service is no longer running.
- 14.2 **Overhanging bushes obscured view from Great Elm:** Alan Brady to approach owners.
- 14.3 **Speedwatch:** One member is stepping down but it is hoped that two more members will be joining next month after they have received training.
- 14.4 **Notification of resignation:** Chris Tye informed the council that he would be standing down after the next meeting after 13 years on the council.

- 14.6 **Hansons Quarry Liaison meeting:** There have been 7 noise, 2 dust and 3 blasting complaints. The quarry has twice exceeded its blasting limits but these occasions were not complained about. Over the next 12 years the quarry will be sinking three more levels.
- 14.7 **Wind turbine:** Vince Turner informed the PC that he had been approached by a company who wish to put a community turbine on his land which would generate revenue for the village. The previous proposed wind turbine received a lot of opposition from Leigh on Mendip.
