05.07.23 SOMERSET COUNCIL - COUNCILLOR'S REPORT: (Report sent in absence)

- i. Three-year Council Finances: When the 2023/24 budget was agreed in February 2023 the forecast gap over the next three years was outlined as £100m. However the latest Executive report states that the expected gap for 2024/25 of circa £40m will now be considerably higher. The report also states that it is imperative that action be taken to identify significant savings. The same Executive report also shows an accumulative budget gap of £98.8m in 2026/27.
- **ii. Waste Services Industrial Action:** Waste Service members of the Unite union intended to start industrial action on 12 July but this has now been postponed for two weeks.
- **Customer Access Points:** From July, Customers who need in-person help or advice from Somerset Council can find support in all Somerset Libraries. They will be able to set up virtual, face-to-face meetings on the spot so people can speak directly to a member of the Customer Service team. The support will be provided during library opening hours, which, in most cases, includes weekends.
- **Surface dressing programme:** The Highways team have started to surface dress (a recognised maintenance technique for sealing a road, improving skid resistance, and preventing water getting under the surface) some roads as part of the summer maintenance programme. The work can only be carried out in dry weather, so the Council's surface dressing programme is flexible, and dates can change at short notice. 06.07.23 APPROVAL OF PREVIOUS MEETING MINUTES HELD ON 13 JUNE 2023

07.07.23 MATTERS ARISING

- **Barn lease:** A draft lease has been returned to the Diocese. If agreed, it will be passed to the Barn committee and finally to the PC for approval.
- **Pavilion improvements:** Awaiting planning decision. Funding the planned improvements will be an issue as there is only a few years left on the lease. The Recreation Ground insurance had increased by nearly £800 which was not acceptable to the PC. After discussion it was agreed to pay £1,082.07 with Mells Sports and Recreation Ground Company paying the rest. The Company will need to find a way to fund the insurance in the future as this is fast becoming an expense the PC cannot afford.
- iii. Millennial seat: Cllr Brady has repaired this bench and the one by the Cricket Pavilion.

08.07.23 HIGHWAY AND FOOTPATH ISSUES:

- i. Condition of grass triangle Bottom Lane and area in front of Vobster Inn: Consultation period ends 16 July. If no objections are received, it is hoped the licence will be issued for signing and the works can move forward. Post meeting notice: One objection has been received. The objections raised will now be investigated and according to how complicated they are to address, there maybe an increased fee for the PC to cover.
- ii. Footway by quarry: No action has been taken yet.
- **iii. Vobster drive carefully signs:** Clerk has accepted the new quote which was £273 higher than the previous one.
- **iv.** Passing places Selwood Street: Clerk to chase Highways again. The placement of larger signage in strategic places (by the Post Office, the garages by The Talbot and near Longfield) around the village is being looked into. Cllr Seewooruttun will investigate.
- v. Accidents on Park Corner: No response from Highways. Clerk to chase white lining.
- vi. Fingerposts: No response from contractor. Clerk to chase.
- vii. HGVs Top Road: No response from Highways. Clerk to chase.
